MEMORANDUM

Complainant alleges that a judge from the United States District Court for the District of Columbia has engaged in conduct prejudicial to the effective and expeditious administration of the business of the courts. Although it is difficult to determine the true nature of the complaint, it appears that complainant is alleging that the subject judge has denied complainant access to the courts by refusing to file complainant's petition for writ of habeas corpus. Complainant's allegation, however, does not provide any grounds for action against the subject judge.

Complainant alleges that the subject judge has denied complainant access to the courts by failing to file complainant's petition for writ of habeas corpus. A review of the document complainant attempted to file and the correspondence that the subject judge sent to complainant reveals that complainant neglected to include the name of the respondent in the pleading and did not complete and sign the application to proceed in forma pauperis. Complainant was notified that although the pleading was not filed, the pleading could be resubmitted upon correction of the deficiencies. Thus, complainant's allegation against the subject judge lack any evidence to raise an inference that misconduct has occurred. See U.S.C. 352(b)(1)(A)(iii) and Jud. Conf. U.S., Rules for Judicial-Conduct and Judicial-Disability Proceedings 11(c)(1)(D).

Because the allegation lacks any evidence to raise an inference of misconduct, the complaint must be dismissed.¹

¹ Pursuant to 28 U.S.C. § 352(c) and Jud. Conf. U.S., Rules for Judicial-Conduct and Judicial - Disability Proceedings 18(a), complainant may file a petition for review by the Judicial Council for the District of Columbia Circuit. Any petition must be filed in the Office of the Clerk of the Court of Appeals within 35 days of the date of the Clerk's letter transmitting the dismissal Order and this Memorandum. *Id.* R. 18(b).
