MEMORANDUM

Complainant has filed a Judicial Complaint alleging that a judge of the United States District Court for the District of Columbia has engaged in conduct prejudicial to the effective and expeditious administration of the business of the courts. In accordance with 28 U.S.C. § 352(a), the complaint has been "expeditiously review[ed]." The subject judge retired from active service effective March 16, 2016. In consequence thereof, the complaint proceeding is concluded under 28 U.S.C. § 352(b)(2), as "action on the complaint is no longer necessary because of intervening events." See 28 U.S.C. § 352(b)(2); see also JUD. CONF. U.S., RULES FOR JUDICIAL-CONDUCT AND JUDICIAL-DISABILITY PROCEEDINGS 11(e) ("The chief judge may conclude a complaint proceeding in whole or in part upon determining that intervening events render some or all of the allegations moot or make remedial action impossible.")¹

¹ Pursuant to 28 U.S.C. § 352(c) and JUD. CONF. U.S., RULES FOR JUDICIAL-CONDUCT AND JUDICIAL -DISABILITY PROCEEDINGS Rule 18(a), the complainant may file a petition for review by the Judicial Council for the District of Columbia Circuit. Any petition must be filed in the Office of the Circuit Executive for the D.C. Circuit within 42 days of the date of the dismissal order. *Id.* Rule 18(b).
