MEMORANDUM

Complainant alleges that a judge of the United States Court of Appeals for the District of Columbia Circuit "is substantially involved in significant illicit activity" including "drug/human trafficking of an enormous magnitude" and "hostile retaliation, malicious mischief, vandalism, and egregious human rights abuses...." Because the allegations are frivolous, the complaint is dismissed. Jud. Conf. U.S., Rules for Judicial-Conduct AND Judicial-Disability Proceedings 11(c)(1)(C); Commentary on Rule 11 (stating that dismissal of a complaint as frivolous is appropriate "when the allegations are facially incredible or so lacking in indicia of reliability that no further inquiry is warranted"); 28 U.S.C. § 352(b)(1)(A)(iii).1

Pursuant to 28 U.S.C. § 352(c) and JUD. CONF. U.S., RULES FOR JUDICIAL-CONDUCT AND JUDICIAL-DISABILITY PROCEEDINGS, Rule 18(a), the complainant may file a petition for review by the Judicial Council for the District of Columbia Circuit. Any petition must be filed in the Office of the Circuit Executive for the D.C. Circuit within 42 days of the date of the dismissal order. *Id.* Rule 18(b).
