J U D G M E N T

ORDERED AND ADJUDGED that the district court's order filed August 22, 2006, be affirmed. The district court properly dismissed the complaint sua sponte under 28 U.S.C. § 1915(e), because the allegations lack an arguable basis either in law or fact. See Nietzke v. Williams, 490 U.S. 319, 325 (1989); Crisafi v. Holland, 655 F.2d 1305 (D.C. Cir. 1981).
