#### JUDGMENT

This appeal was considered on the record from the United States District Court for the District of Columbia and on the briefs filed by appellant. See Fed. R. App. P. 34(a)(2); D.C. Cir. Rule 34(j). It is

**ORDERED AND ADJUDGED** that the district court's order, filed January 17, 2018, be affirmed. The district courts of the United States are "courts of limited jurisdiction. They possess only that power authorized by Constitution and statute." <u>Kokkonen v. Guardian Life Ins. Co. of America</u>, 511 U.S. 375, 377 (1994). The district courts have jurisdiction in "federal question" cases, i.e., civil actions arising under the Constitution, laws, or treaties of the United States, 28 U.S.C. § 1331, and in "diversity" cases, i.e., civil actions between citizens of different states or between United States citizens and foreign citizens or foreign states, provided the matter in controversy exceeds \$75,000, 28 U.S.C. § 1332. In this case, appellant failed to plead facts to establish federal question jurisdiction or diversity jurisdiction.
